



Privacy Policy

1. General

These privacy regulations contain the privacy policy of Broeck Oudewater B.V.. When you provide us with personal data as a guest, employee, or client, we will store and process this information following these privacy regulations, unless stated otherwise. We will always process your data in compliance with the General Data Protection Regulation (GDPR) and other applicable regulations regarding the protection of personal data.

2. Responsible

Broeck Oudewater B.V., located at Broeckerstraat 20, 3421 BL Oudewater, is responsible for the processing of your personal data. Chamber of Commerce 81098383.

3. Visit website

In general, our website can be visited without your personal data being passed on to us. However, this website does collect certain technical information about the users of the website, such as the IP address of your computer, the date and time of your visit, and which pages you visit. However, this information is only used by us in aggregated and non-personally identifiable form; for the management of the website and to make the website more user-friendly and relevant. We currently do not use cookies and similar techniques. Our website may contain references and/or hyperlinks to one or more websites of third parties. These privacy regulations do not apply to those websites and we recommend that you read the privacy policies of these third parties so that you are aware of how they handle your personal data.

4. Why do we collect personal data?

We collect and process your data for the performance of our services, including analyzing your behavior on the website to improve the website and to tailor the range of products and services to your preferences. More specifically, we process your personal data: To be able to make you offers and/or to provide information about our services and other activities and to better tailor them to your wishes and qualities. To contact you for commercial offers, newsletters, and promotional campaigns that may be of interest to you, only if you have registered for them (opt-in);

5. What information do we collect from you?

We process the personal data that are necessary for our services. You are responsible for the correctness and relevance of the information you provide. More specifically, the following personal data of guests is processed, insofar as relevant and necessary: name and address data (name, address, place of residence), e-mail address, telephone number, IP address, other personal data that you actively provide, for example through a profile on this website. to create, in correspondence and by telephone, location data, data about your activities on our website and data about your surfing behavior across different websites The personal data is processed insofar as this is necessary for the optimal performance of activities and the use of our services. We may pass on your personal data to (potential) clients and relations, suppliers (for example training authorities), audit authorities, government institutions, subcontractors, and to companies and/or persons that we have engaged to perform certain tasks (including processors). Also, we can provide your data to third parties if we are entitled or obliged to do so based on the applicable laws and/or regulations, a court order or a judicial decision, or if we have received permission from you.

6. Special personal data

We only process special personal data if this is necessary to comply with our legal obligations, insofar as explicit permission has been given, or insofar as this is otherwise permitted by or according to the law. By “special personal data” is meant data about race, religion or belief, political opinion, health, sexual life, trade union membership, criminal personal data, and/or personal data about unlawful or annoying behavior.

7. How long are data kept?

We do not store your personal data longer than is necessary for the purposes for which this data was collected and we comply with applicable laws and regulations. Periodically it is checked whether it is still necessary to keep the personal data.

8. Security and Confidentiality

We think it is important that your personal data is well protected. We, therefore, take appropriate precautions to protect your personal data against loss or any form of unlawful processing and also require third parties who treat or process your personal data for us to do the same, regardless of whether this processing takes place in the Netherlands or elsewhere. These measures include both technical and organizational measures. Technical measures include physical and password protection. Organizational measures include, for example, limiting access to qualified personnel with a duty of confidentiality. The measures that are taken guarantee an appropriate security level given the risks of the processing and the nature of the data to be protected.

9. Access, correction, or deletion
